## COOLED TRANSPORTED SEMEN AGREEMENT or FROZEN SEMEN AGREEMENT

I hereby agree on this the \_\_\_\_\_ day of \_\_\_\_\_ 2007 to breed the mare below to the Stallion,

**Hot Impulse**, Reg. #3452436 for the 2007 season using cooled transported semen subject to the following conditions:

Tom Chown/Willowtree Farm, agent for the above named stallion, will herein be referred to as stallion owner.

The Total Breeding Fee for **HOT IMPULSE** the 2007 season is: \$ \_\_\_\_\_ payable to Tom Chown/Wilowtree Farm (This Total Breeding Fee is broken down separately as Stud Fee \$ \_\_\_\_\_ and non-refundable Booking Fee \$ \_\_\_\_\_.)

The Chute Fee shall be payable upon execution of this contract. The balance of the stud fee shall be payable a minimum of (10) days before semen will be shipped unless the stud fee is paid with cashiers check, money order, or credit card which may be paid anytime prior to shipment. At no time will any shipments be made without the Total Breeding Fee being paid in advance. There is a \$275.00 fee per shipment of cooled semen which includes shipment via Federal Express. Additional charge of \$25.00 for Saturday Federal Express deliveries. If Semen is picked up at the ranch, the fee is \$175.00 per semen packet per mare. If shipment needs to be sent same day via Air Cargo, the customer will pay a \$350 shipped semen fee prior to shipment of semen. All semen shipment fees and or semen pickup fees MUST BE PAID prior to shipment.

1. Stallion Owner will begin shipping cooled semen in February of the current breeding season and end in July. **A request for a shipment of cooled semen must be made by 5:00pm C.S.T. the evening prior to shipping time. Frozen semen will be handled thru Select Breeders.** Cancellation must be made by 8:00 a.m. C.S.T. on shipping day to avoid a \$75 cancellation fee. Any late orders for semen that involve hiring a courier to deliver semen to a Federal Express drop-off location will result in a \$50 courier fee. We will ship on a first requested, first served basis. At no time will the Stallion Owner make a guarantee that cooled semen will be available for a specific day.
2. The Stallion Owners have the right to set a limit of two (2) shipments per breeding cycle per mare and five (5) shipments per breeding season per mare.
3. Stallion Owners agree to ship cooled semen as described above. If a mare fails to settle for any reason, mare owner will hold Stallion Owners blameless.
4. A Live Foal Guarantee will apply (except as provided in this paragraph and in paragraph 5 below) for one year to those mares that conceive and carry a pregnancy at least sixty (60) days from insemination. To be eligible for a live foal guarantee, a confirmation of pregnancy must be submitted from a veterinarian in the form of a documented ultrasound picture prior to the end of current breeding season. A live foal is described as a newborn foal that stands and nurses without assistance. If the foal is born dead, return privileges shall apply only if Stallion Owner is notified within seven (7) days thereof and receives a veterinarian's statement confirming death within 30 days. Return privileges shall apply only to the next normal breeding period. A non-refundable rebreed Chute Fee must be paid prior to the mare being rebred. A substitute mare may be sent only if the original mare has died or is deemed unfit for breeding at the sole discretion of the Stallion Owner. No refunds will be given at anytime for any fees including the stallion breeding fee, chute fee or semen shipment fees.
5. The parties further agree that should the Stallion die or become unfit for service for *any* reason, then this contract shall become null and void (including the live foal guarantee) and both parties are relieved of any further obligation hereunder except that Mare Owner shall pay for all other expenses actually incurred including the payment of the breeding fee and all shipped semen fees. The Live Foal Guarantee in this contract is non-transferable and non-assignable and should Mare be sold or otherwise disposed of prior to the birth of the foal, the live foal guarantee shall be void. In the event the Stallion Owner agrees to the transfer or assignment of the "live foal guarantee" rights under the terms of this contract, then the new owner agrees to be bound by all terms and conditions hereof, insofar as the same may then be applicable. No refunds will be given at anytime for any fees including the stallion breeding fee, chute fee or semen shipment fees.

6. **Mare owners that chose not to breed via shipped semen may take their mare to the breeding farm. Board fees are as follows: A daily rate of \$12/per horse for pasture care, A daily rate of \$13/per horse for the mare motel and A daily rate of \$16/per horse for the show barn. Foaling fee \$350.00 per mare.**
7. A Breeder's Certificate will be issued to the mare owner after all expenses have been paid in full and upon notification of the birth of the foal.
8. The parties acknowledge that this agreement is made and shall be entirely performed within the County of Denton, State of Texas and shall be construed and enforced under the laws of the State of Texas.
9. When the mare owner signs and returns this contract to the Stallion Owner and the Stallion Owner signs this contract, it will then become a binding contract on both parties subject to the above terms and conditions, except by written mutual consent of the parties thereto.
10. A PHOTO STATIC COPY OF THE REGISTRATION PAPERS (BOTH SIDES) ON THE ABOVE NAMED MARE MUST ACCOMPANY THE SIGNED CONTRACT. Owner recorded on the Registration Certificate will be recorded on the Stallion Breeding Report.

Please make sure to have your Federal Express shipping address ready

If shipping via the airlines for same day service, please have the airport that you wish to ship to ready

### Shipping Days:

(every other day including weekends)

- Shipments *sent* on Saturday or Sunday will need to be flown in via the airlines as Fed Ex does not pick up on those days.
- Shipments sent on Friday will need to go to a Federal Express address that has Saturday delivery (if your home address or vet's office does not have Saturday delivery, this can be sent to a business close to you or to a Federal Express airport location—just make sure it has Saturday delivery availability).

### Payments

If your mare progresses more rapidly than you expect and you need a shipment that hasn't been pre-paid, just call us....we accept Visa and MasterCard for your convenience.
